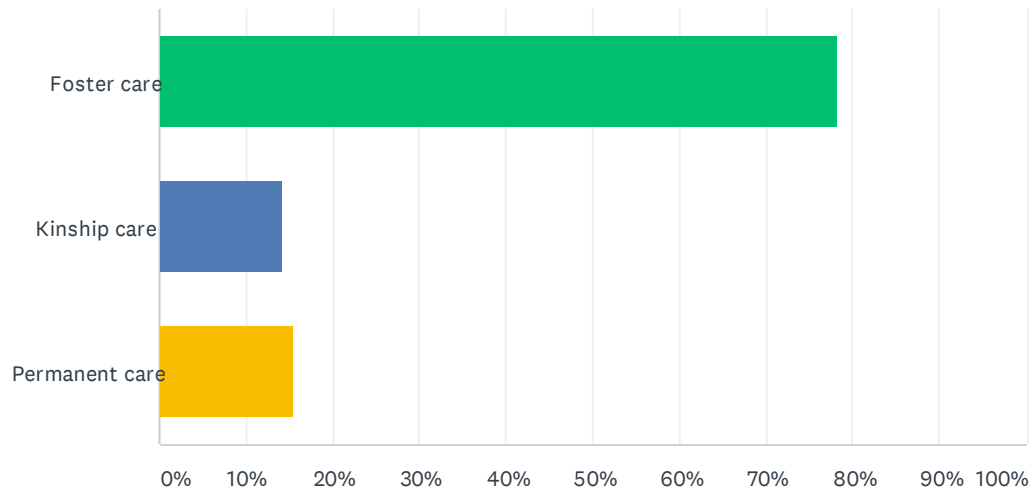


## Q1 Please identify type of care you are providing (click all that apply)

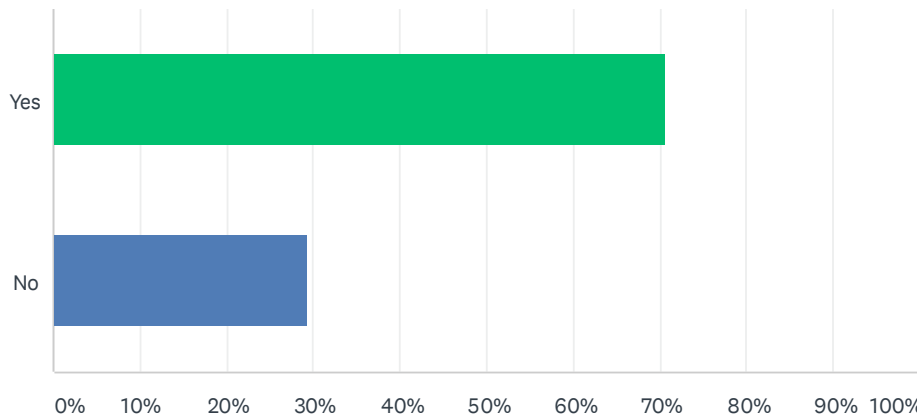

## Q2 Has your carer family struggled more than usual during COVID-19?

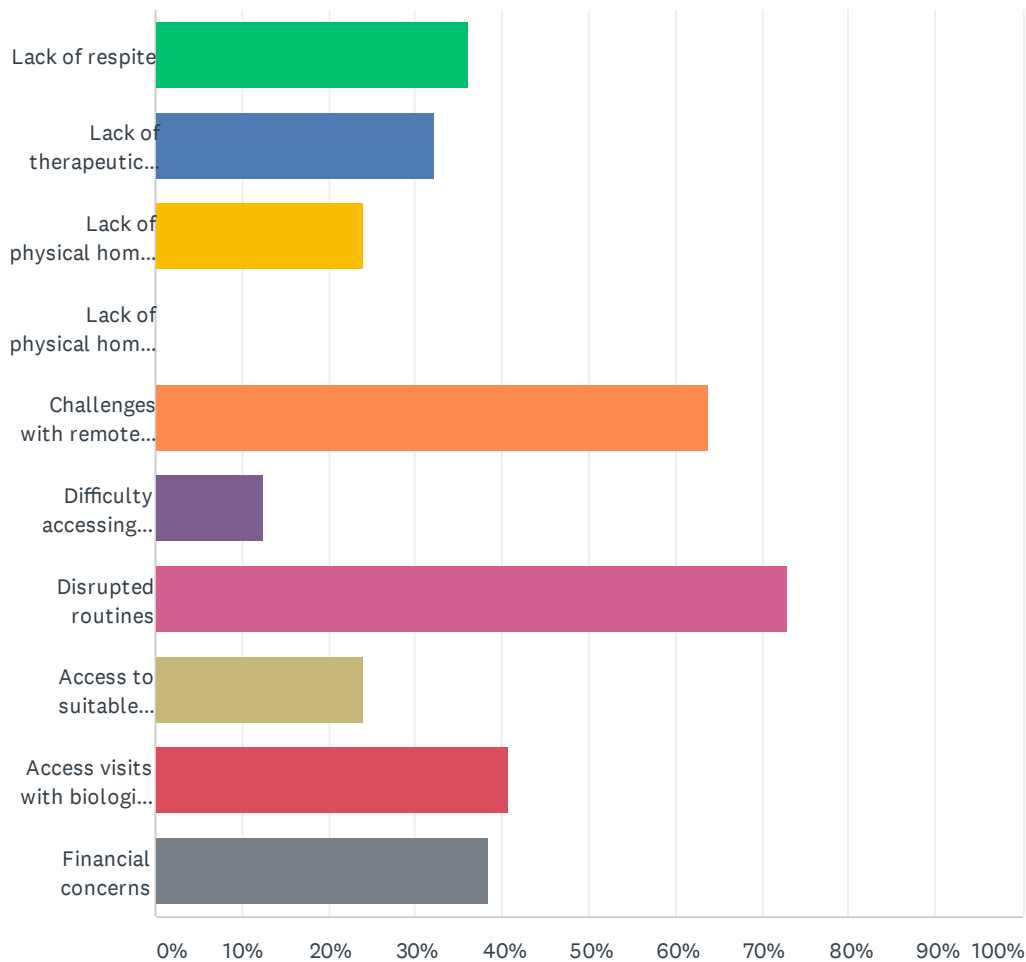

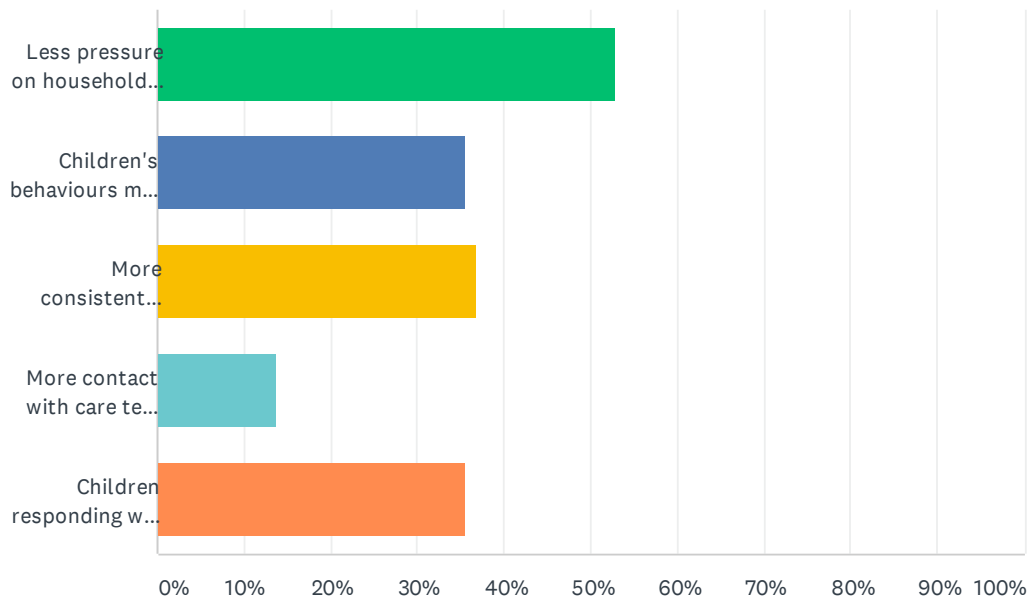

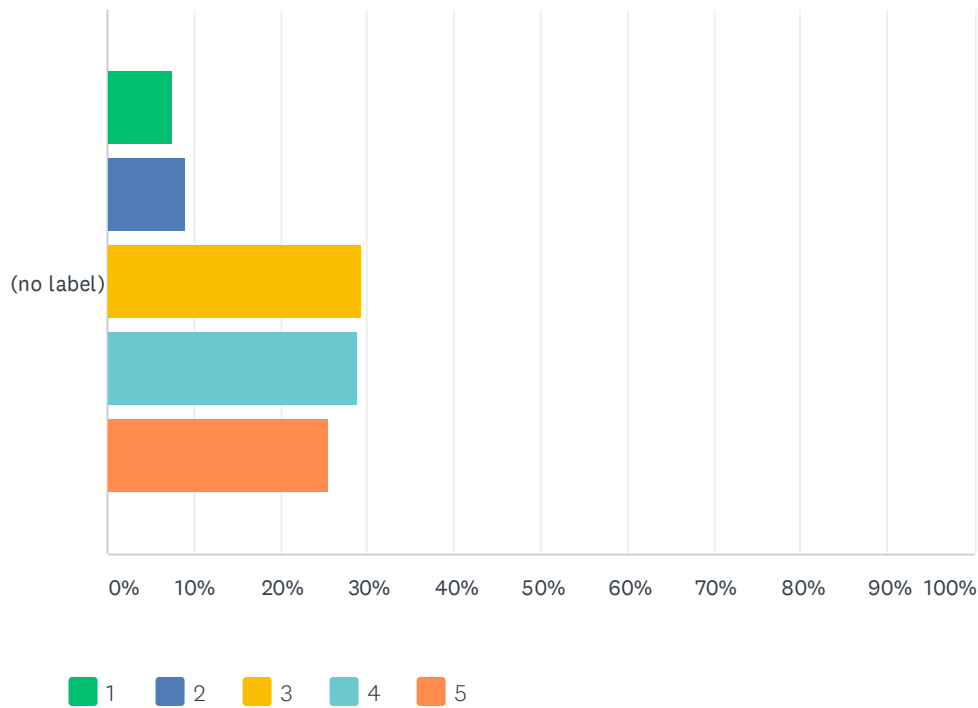

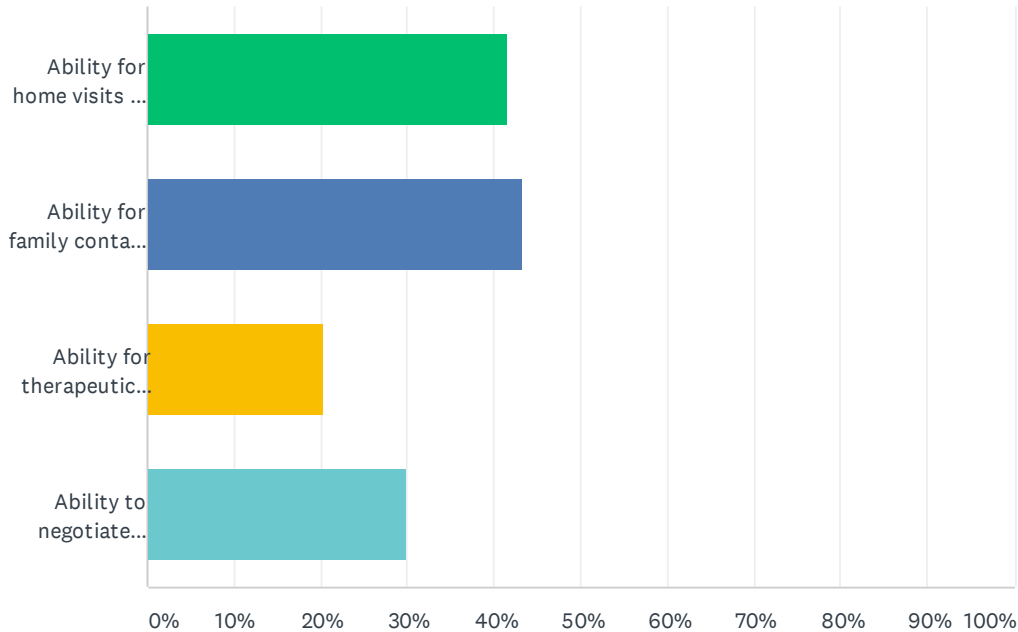

## Q6 What has worked well for children and young people in your care during COVID-19 that you would like to see continue (click all that apply)

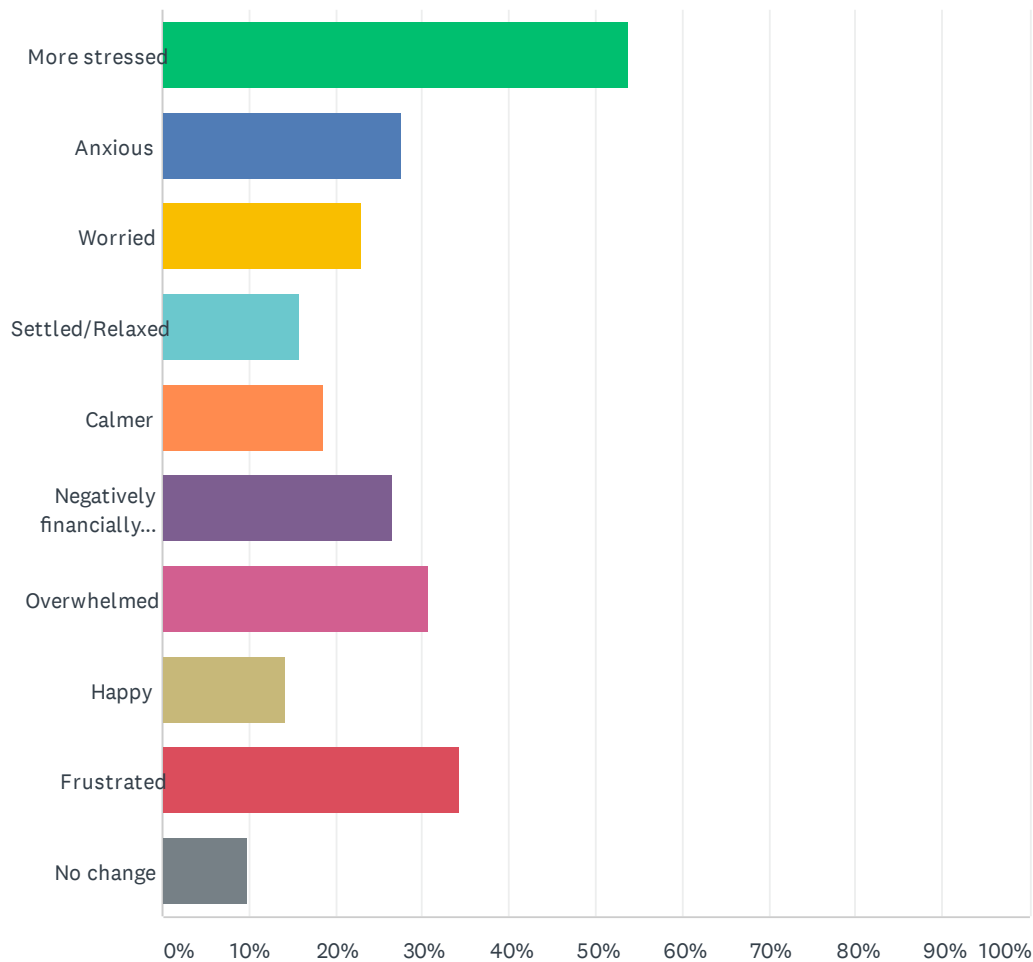

### Q7 What has been the overall impact of COVID-19 on your carer family as it relates to your role as a home-based carer (click all that apply)

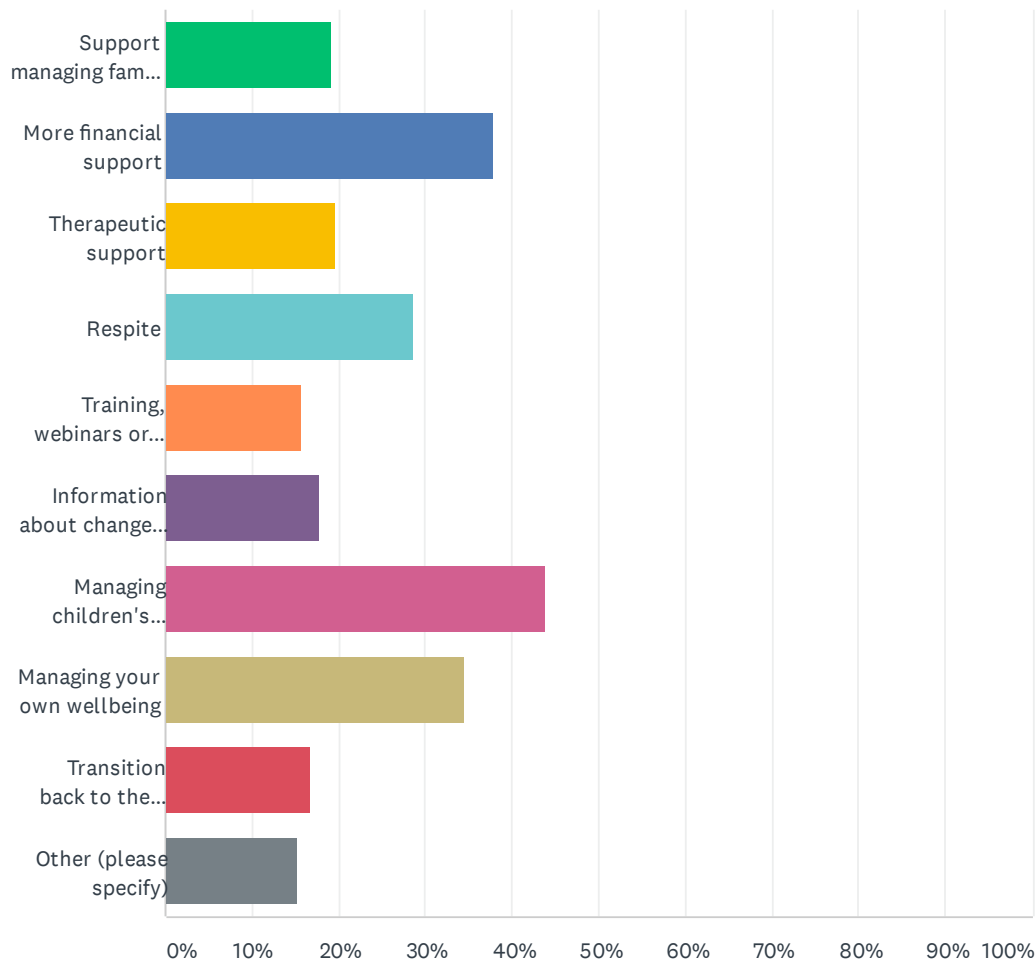
